**A MAYOR AND SIX COMMISSIONERS,  
EACH TO SERVE FOR A PERIOD OF TWO YEARS.**

**WHEREAS**, there came to be considered the returns of the general election held on the 7th day of May 2022, for the purpose of electing a Mayor and six Commissioners, each to serve for a period of two years, hereinafter named officials, and it appears from said returns, duly and legally made, that there were 2,729 cast votes at said election; 2,227 valid and legal votes were counted; cumulative and precinct reports are attached hereto as **Exhibit "A"**, and that each of the candidates in said election received the following votes:



**SECTION 4:** That this Resolution shall be in full force and effect from and after its passage and adoption.




